



BLACK DISTORTION

IS IT A PROBLEM?

These facts are for church goers and biblical conscious people who seek reference to biblical facts for clarity about the plight of the black man as a race, the various names that were attributed to him and how European Christianity succeeded Hellenistic Judaism and the movement from Marcus Aurelius and Constantine.

The philosophers never won since Christianity called for Jew, Gentile and barbarian -rich, poor. Analytic skills can be used to understand various biblical doctrines including the Mormon teachings and the ancient Hebrew teachings and how the order of the day dictated the religious philosophy. Blacks played a role in the nucleus of the Roman Catholic church and the Mediterranean Egyptian (Sais) Sea.

These notes will show in a nut shell the historical developments and the movement of Blacks in the early centuries and how they maintained their positions before the age of distortion. Certain facts need to be clarified about the Arabs (Moslem), the Israelites (Jews) and the Moors (Black Moslems).

Sais (Egypt) was occupied by Blacks when the Hebrews arrived in Egypt with Abraham, and before Abraham, the first Hebrew, was born black and therefore, needed no mythological story of Ham to establish Black identity.

Blacks were Popes long before the Roman Catholic Church and for centuries prior to the arrival of the first White man in West Africa. Christendom owes its greatest success to indigenous Blacks and their contributions before and after the Christian era. The first

martyrs of Christendom were Blacks--Namphamo born in Numidia, an African state that occupied the present area of Libya and Algeria. Tertullian, Pyprian, and Augustine were

patrons and saints. Tertullian, the first church writer, made Latin the language of Christianity. Pyprian was bishop and martyr. Augustine was father of the church and one of the most famous. (Book Mission and Expansion Vol. 111 p. 275).

King Solomon was not known to have written any literary works before occupying the Hebrew throne in 970 BCE which was during the rule of the 21st Dynasty of Egypt. The Papyrus was written 100 BCE at least 31 years before Solomon ruled Palestine and before he is credited with writing the Proverbs.

Following the religious history of the Hebrew people, Moses' commandments and Diety concept came from the training he received in the laws of the "Mysteries of Egypt" in the Hebrew Torah <u>Showing African Birth.</u>

The entire Psalms, Songs of Solomon, and the Hebrew Torah (Christian Old Testament) are word for word from the African, Egyptian, Nubian, and Cushites Ethopian sayings and teachings. All the earliest Hebrews in Genesis and Exodus were Africans born in Egypt and Ethiopia. Monotheism, one God above all others, was taught in Egypt before the birth of Moses by the Pharoah, Akhnaten (Amenhotep IV) 1370 - 1352 BCE. Moses did not live until the rule of the Pharoah Rameses I, 1340 - 1320 or Setl I, 1318 - 1298 BCE. It was during the period of Rameses II, 1298 - 1232 BCE at which time Moses was more than ninety years old

that one hears of Moses receiving the "Ten Commandments" from Jehovah (Yavh God). (Peet Egypt and Old Testament, 1922).

The Egyptian "mystery system" which was founded on the theory of Philosophy in Salvation was seized by Ptolemy I, Alexander the great general, and given to Aristotle and other Greek looters. Books were burned and some taken to Greece.

Ptolemy II ordered the Greeks and Hebrews to translate the Hebrew Torach -Old Testament of the Christian Bible, into Greek.

Mystery system names established by Egyptologist for the system of order that existed in ancient Egypt with regards to religion and education in all disciplines.

All the holy temples of the Ancient Monomotapa Empire seat of Government in Zimbabwe were built by Blacks. What Michaelangelo did was to paint the European version of the christian God, Jesus Christ, like any Italian in view of the fact that the statue of Isis and Osiris depicting the indigenous African Goddess and God of Sais (Egypt) had been initiated and projected as the Black Madonna and Child. Yet the child Jesus Christ grew-up to be a "White Man", and Mary a White Woman. But the statue of Isis and Osiris still remains black, the same as the original Madonna and Child statue in Europe, even in St. Peters church in Rome.

Palestine during the life of Jesus Christ was Hebrew, and that was not the white man's homeland.

What the Europeans brought was white supremacy under the disguise of a Europeanized version of christianity.

"<u>NOTE</u>": Jews (Orthodox Hebrews) are the Yemenites now in Israel and the Beta Israel (Falasa or Falash) the blackest of the world's Jews most of whom lived in South Cush (Kush modern Ethiopia).

"Osiris", the great God, the Prince of Eternity of the Egyptian Religion, remained unchanged from the 5th and 6th dynasties down to the period that embraced christianity --preaching of St. Mark and the Apostle in Alexandria AD 69.

Thebes was great before Alexander the Great arrived. It was broken when the Arab tribes overran the land. While white writers referred to the dynasty as "Thinite" "Memphite" or followers of Seth. One must know that the first dynasty was African and Memphite or Thinite were names of their sacred city and "Seth and Amon" were Africans. Religion to the African was more than a ritual, it reflected reality, their way of life. They believed in immortality and also life after death. That is why large buildings were built to stand forever. They knew mathematics and architectural designs. The great temples such as the city of Amon contained the gods of the king and of his wife, the great goddess, Rhea (Nut). There was also a war God of Thebes which was looked to as the source of power for the armies. **Note**: The African

religion had science and learning, art, engineering and architecture: the resources for a national economy and political control. Mother of history, of writing, of music, the healing art, the song and the dance.

The Thebans were the oldest (first) men of earth according to their tradition. They also originated the system of Philosophy and Astrology. Diodorus supports the fact.

For more than 1,000,000 years the Black man occupied Alkebu-Lan and was never called negro. He was referred to as Ethiopian, Libyan, Nubian, Black, African. The name negro was applied after the European colonialists arrived in the 16th century. Europeans could not pronounce African words so they used terminologies and sounds they could comprehend.

The Empire of Ghana flourished in what is now known as French West Africa during the dark ages of Western Europe. In the 15th century the Univeristy of Timbuktu flourished. We have to rid our minds of the European preconceptions that influence our thinking on the subject of civilization. Social organization survived in the simplest African communities and the Ashantis of the Gold Coast. The Yorubas of Nigeria possessed complex civilizations. Africa is thus today accepted by many scientists as the cardle of human species, e.g. Africa around the great Lakes and the Nile Valley from Tanganyeka to the Mediterranean Sea is the cradle of man's civilization. Cushites (Ethiopians), Nubians (Sudanese), Agikuyu (Kenyan), Egyptians (Sais)--presently Arabized Africans--and Arabs (Gandas), Uganda (Masais), Tanzania, and others along the more than 4100 mile length of the Nile River Valley (from Uganda to the Mediterranean Sea). Rozwis--builders of the stone structure of Zimbabwe--the Swazis, and Sethos of Monomatapa (South Africa) in order to claim Tanzania's Zinjanthropus and South Africa's Baskap Man.

Blacks were responsible for the early education of the first and greatest of the light skinned caucasian. The Greeks patterned their lives after the education they received in Africa. They wrote about their apprenticeships under indigenous Africians. The Romans also wrote about this fact. The Europeans benefitted from universities of Sankhore in the city of Tombut (Timbuktu), Melle (Mali) and through other educational contact.

Alkebu-Lan, Ethiopia, Corphye, Ortegia, Oceania Libya, Hesperia, Land of the Spirits, Land of the Gods and various other names were given to this continent by the Ancients:

- (1) Nile Valley Africans
- (2) South African
- (3) West Bound African

Tanganyika (Tanzania) has so far proven to be mankind's oldest home (Garden of Eden). Zinjanthropus baisie 1,750,000 years old was unearthed in this area.

The river Ganges in India obtains its name from the Ethiopian General, Ganges, who ruled upper, middle lower Egypt from the Nile Valley to Uganda. Also the Elamites (Blacks) settled in Persia after being driven out from Egypt by Usertsen the fifth Pharoah of the 25th dynasty. Conqueror ports of Nubia (Sudan) were responsible for the civilization of Elam. These facts support the idea that ancient Egypt lived long before the first Asian or European invaders. The Hyksos, in 1675 BC, also Blacks, were in Egypt before the stone age culture.

The first five dynasties characterized by great leaders ruled over a period of 755 years. Menes, Atothones, Peribsen, Khasekhem, Imhotep, Zoster, Sneferu, Khufu, Khafre, Userkaf, Neferefre and others who re-established Ethiopian power. They held it without serious challenge for almost 1,000 years. It was during this period that agricultural, industrial development, the arts, engineering, massive building programs, mining and ship building were extensive. Hence Imhotep is noted as the world's greatest architect and the father of scientific medicine. The Palemo Stone Annals was completed in the 6th dynasty. Fourth dynasty chief pyramid builders reign of Khufu 2590 - 67 BC largest and highest until modern time. Khufu's nephew Khafre built the second pyramid the great sphinx, and settled the question of his racial identity for all ages. His African features so boldly and cleanly carved into a portrait that not even a fool could seriously doubt his Africaness. Note or short point: Decentralization of power, religious conflict/weakening of the

dynasty Asians ruled lower Egypt under Khet I. Mixture of race Afro-Asians outnumbered Asians. In the 18th dynasty there was a line of kings and queens who Ahmose I, Nefertari (woman), Amenhotep II, Thutmose I, became immortal. Thumose II. Queen Hatsheput, Great Amenhotep III, Ikhnaton, the great reformer and Tutankhamen. It was called the New Empire. Note: Thutmost III removed his sister's name Hatshepsut from monuments she erected and placed his and her brother's name. Prince Sequenra III fought the Hykos in 1580 BC. His mummy is in the Cairo Museum. Ahmes drove the Hyksos from Egypt into the Palestine Hebrew city of Sharukhena. It should be noted that the greatest Hebrew invasion of Egypt occured about 600 years before Moses and the captivity. Historians only relate to Egypt with Alexander's son, and Philip, of Macedona. His success was due to the Blacks who wanted to do away with the Persians who ruled Egypt. Then the Greeks enslaved the Egyptians.

Alexander the Great died mysteriously 311 BC, thus giving way to his general Ptolemy I who married an African woman who gave birth to Ptolemy II. Ptolemy I ruled all Egypt and ordered the mystery system seized by Aristotle and other Greek looters. Ptolemy II was responsible for the building of the Pharoah lighthouse and he translated the Hebrew Torach (Old Testament into Greek). Also it was in his day that <u>Manetho</u> the High Priest DIVIDED Egypt into dynasties and published the history of

Egypt. This was the only created period of light skinned caucasians' colonial rule over indigenous Africans of Egypt (Manetho was born of an indigenous black mother and a Greek white father).

The Ptolemy rule was an age of murder among the royal family. Ptolemy IX overthrew his brother Ptolemy VIII. Ptolemy murdered Cleopatra Bernice his wife. Ptolemy XII deposed his sister Cleopatra VIII. Julius Caesar reinstated Cleopatra VIII, 47 BC. She was of White (European) and Black (African) parentage. Her European lineage was from <u>General Soter</u>, Ptolemy I. All the Ptolemies (II - XIV) descended from this beginning.

Ptolemy XII was murdered, by drowning at the hands of his sister--Cleopatra VIII.

Ptolemy XIII was appointed co-regent with Cleopatra. She immediately planned his execution.

Julius Caesar appointed Ptolomey XIV, his son to rule jointly with his mother Cleopatra.

Cleopatra VIII committed suicide after being discovered in a plot with Marc Anthony to dispose of Julius Caesar.

Octavianus later called Augustus Caesar, defeated Marc Anthony in the Battle of Acluun during 30 BC. This juncture was the end of the Pharonic period of the Greeks. Egypt became a common province colony of the Roman Empire.

Note: Greeks who studied in Africa: Herodous--who spoke about the large statue built by Khufu but he could not pronounce African words--Socrates, Hypocrates Anascagores, Arislophanes, Plato, Aristotle and others. Even the Athenian government prosecuted Socrates for teaching the philosophy.

There were two cultural groups of Moors that entered Europe. Spain was captured by General Tarikh who was the first black man to capture the first part of the Iberian Peninsula. He accomplished this in 711 CE. The Black Moors civilized the Spanish and extended their rule for 200 years to 1485 CE in Granda. In all other parts of Spain the Arab

Moors had been driven out by the christian Spaniards in 1285 CE. The African Moors were the first to enter Spain in 711 CE and were the last to leave in 1485.

Gibral Tarikh fought the Arab Moslems from Arabia in 680 CE before being captured by them and later became a Moslem. There is a deliberate attempt to make all of the black people who conquered and ruled Spain, Portugal, and parts of Southern France from Africa (Alkebu-Lan), Arabs. [Facts: General Setenius Flaccus in the year 50 BCE penetrated the Sahara and Julius Maternus reached around Lake Chad.]

The Arabs dominated Africa for 1327 years. They came to the Sudan about 1,000 AD where there was a well arranged system of commerce. They first visited Alkebu-Lan by western route in the 8th and 9th century of our era.

They found black kings of Ghana in the height of their prosperity--Moorish King Zufe, King Monomotapa of Zimbabwe and Lower Ethiopia. Arab conquests were not African brotherhood, but Arab imperialisms.

Hannibal, the greatest African general and the world's greatest military strategist to date, at age 30 made Carthege the world's greatest single military power, and defeated Rome (216-214). Africans were masters of the Mediterranean world. Nations were panic-stricken and in 213 many joined Hannibal. Greece battle of Zana. In 146 BCE Rome set fire to Carthage.

Note: Carthage (Tunisia) was open to all people. It was a scientific and commercial port. Please note that the indigenous Africans the Europeans called Carthagenians, defeated the Romans during 1st and 2nd Punic wars. Romans defeated them in 3rd final Punic war. Hannibal also crossed the Alps.

Africans interbred with Romans during the 1st and 2nd Punic wars or with the English (Angloland) during the reign of the African Emperor of Rome, Septimus Severus, who died in England in February 211 CE. Severus' son Caralla, who was also Emperor of Rome and succeeded his father, was of African black parentage. Few noted Romans during the christian era--Paul (Saul)--was a Roman citizen. He was Hebrew (Jewish). Seneca the philosopher on politics was from Spain. Remember Rome was not a cultural center of a particular homogeneous ethnic group of people. It was the home of a number of races or ethnic groups.

No attempt is made to find out why the southern European (Italians, Greeks, Spaniards, Slavic peoples, Portuguese, and French are generally dark skinned). Also Europeans of Sweden, Denmark, Norway and Germany who have definitely described black physical characteristics. Also the black population in southern China, Indo China, blacks of Formosa Australia, Malay peninsula, the Andamanas in India, and the fact that the earliest Aryan chiefs were black.
